WAIVER AND LIABILITY RELEASE AGREEMENT

READ CAREFULLY BEFORE SIGNING

I, [PRINT NAME HERE] _____ (hereafter referred to as “Student,” which term includes the parent or appointed legal guardian of Student, (if Student is a minor), am freely and voluntarily seeking to participate in an instruction activity offered, promoted and organized by Harmony Training Stables. This Waiver and Liability Release Agreement will be binding each time now and in the future when Student attends or participates in any event or lesson-based activity that is offered by Harmony Training Stables.

In consideration of Harmony Training Stables allowing Student to participate in instruction or any activity now and in the future, Student agrees as follows:

Risks of Equine Activities/Assumption of Risks. Student acknowledges that there are numerous risks inherent in equine activities, whether preparing for, entering, attending, participating in or leaving a lesson or event. The risks include, but are not limited to: the propensity of a horse or pony (hereafter referred to as “equine”) to behave in ways that may result in injury, harm, or death to persons on or around them; the unpredictability of an equine’s reaction to sounds, sudden movements, and unfamiliar objects, persons, or other animal; certain hazards such as surface or subsurface conditions on or near the land where the lessons or event takes place; and /or collisions with other equines, people, or objects. Student understands these risks and dangers inherent in equine activities and agrees to assume them. Student also understands that these are just some of the risks and agrees to assume others not mentioned above. Student is not relying the Harmony Training Stables to list all possible equine or lesson-related risks. **STUDENT UNDERSTANDS THESE AND OTHER RISKS AND DANGERS ASSOCIATED EQUINE ACTIVITIES AND EVENTS, AND STUDENT VOLUNTARILY AGREES TO ASSUME THEM. STUDENT ALSO UNDERSTANDS THAT THESE ARE JUST SOME OF THE RISKS AND AGREES TO ASSUME OTHERS NOT MENTIONED ABOVE. STUDENT IS NOT RELYING ON HARMONY TRAINING STABLES TO LIST ALL POSSIBLE RISKS.**

Waiver and Release of Liability. With full knowledge and appreciation of these and other risks associated with equine activities and equine lessons and consideration of being allowed to participate in Harmony Training Stables lessons or organized shows now or in the future Student, for himself/herself, corporation, the owners of land or farm grounds, instructors, barn management and their respective employees, agents, representative assigns, offices, directors, member volunteer and affiliates of and from all claims, demands, or causes of action (present and future), liabilities, or obligations, whether the same be known or unknown, anticipated or unanticipated, resulting from or arising if injury, loss of life, or damage that may be sustained by Student or to the Student’s horse(s) or personal property which may occur as a result of attending or participation in a Harmony Training Stables-sponsored instruction or organized event (except if injury, death, or damage is directly caused by Harmony Training Stable’s gross negligence or willful or want misconduct).

WARNING: Under the Indiana Equine Activity Liability Act [1991 p.a. 351], an equine professional is not liable for and injury to or the death of a participant in an equine activity resulting from and inherent risk of the equine activity.

IT IS MUTUALLY UNDERSTOOD AND AGREED THAT THIS WAIVER AND LIABILITY RELEASE AGREEMENT SHALL CONSTITUTE A WAIVER OF LIABILITY BEYOND THE PROVISIONS OF THE INDIANA EQUINE ACTIVITY LIABILITY ACT, 1994 P.A. 351.

Governing Law / Disputes. This Waiver and Liability Release Agreement is governed by Indiana law and is intend to be as broad and inclusive as Indiana law allows. If any clause conflicts with the applicable law, only that clause will be null and void but the remainder shall stay in force and effect. Should Student (or others on behalf of Student) agrees to pay all attorney fees, court costs, and other costs incurred by Harmony Training Stable and /or its employee, agents, representatives, assigns, officers, directors, members volunteers, and affiliates.
